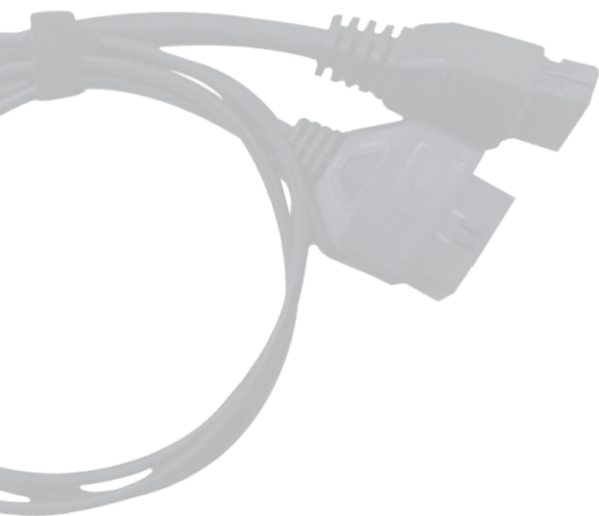

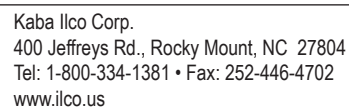

Standard Terms & Conditions of Sale

After Market Sales | Effective Oct. 1, 2024 (rev Aug. 27, 2024) | All Currency in U.S. Dollars

All Sales by Kaba Ilco Corp. (hereinafter "Kaba Ilco") are expressly conditioned on these Standard Terms & Conditions of Sale (the "Terms"). By accepting an offer contained in a Kaba Ilco quotation to which these Terms are attached, or by otherwise purchasing goods from Kaba Ilco, the customer (hereafter "Buyer") creates a legally binding agreement based upon the terms and conditions contained herein (the "Order"). Any terms or conditions included by Buyer in an acceptance of a Kaba Ilco offer and/or included with any purchase order for goods and/or services to be purchased by Buyer (the "Products") shall not apply and are hereby rejected in their entirety. Acceptance of and/or performance by Kaba Ilco of a purchase order from Buyer for purchase of the Products shall not constitute acceptance of Buyers added terms and conditions, if any, unless Kaba Ilco's acceptance specifically states otherwise.

1) **PRICES.** Prices are subject to change without notice and are not guaranteed. All orders will be invoiced at net prices in effect on date of shipment.

2) **TAXES.** Prices do not include any federal, state, municipal, or other governmental taxes, duties, levies, or other charges, including any sales, documentary, use, excise, purchase, turnover and/or import taxes, consular fees, and customs duties. The amount of any such taxes and fees will be added to the purchase price paid by Buyer.

3) **TERMS.** Standard payment terms are net 30 days. Kaba Ilco reserves the right to add a 1½% per month carrying charge on all invoices 30 days past due. For example: an invoice dated April 15th will be considered past due on May 16th and the carrying charge will be added to the May 30th statement.

4) **ORDER ACCEPTANCE.** Kaba Ilco reserves the right to refuse any orders which may be received, and will not be bound to fill any order until it has been accepted. If the order is declined, notification will be provided within 14 working days of receipt of the order. Kaba Ilco makes an effort to identify and correct invalid product numbers. However, orders must contain valid, complete Kaba Ilco product number to avoid delays and assure that the item(s) will be shipped correctly.

5) **CREDIT.** Kaba Ilco retains a purchase money security interest in all goods and materials which have been or are hereafter acquired by Buyer with credit granted by Kaba Ilco ("Collateral"). Upon any default by Buyer, Kaba Ilco shall have the rights of a secured party under the Uniform Commercial Code as adopted by the State of North Carolina, as amended. Kaba Ilco may require Buyer to assemble the Collateral at a place designated by Kaba Ilco. Buyer shall reimburse Kaba Ilco for all costs (including reasonable attorneys fees) incurred in collecting any amounts due to Kaba Ilco or executing its interest hereunder. In addition to any other right or remedy hereunder, Kaba Ilco shall have at all times the right to offset any obligation of Buyer to Kaba Ilco against any obligation of Kaba Ilco to Buyer. If in Kaba Ilco's sole judgement any doubt arises at any time as to the ability of the Buyer to pay for the products, or if the Buyer at any time is past due in payment of any amount owing to Kaba Ilco, Kaba Ilco may (without liability and without prejudice to any other remedies, and regardless of any schedule of shipment or payment to the contrary), delay production, postpone any shipment or stop any product in transit until Kaba Ilco shall have received payment in full of all amounts, whether or not then due, owing to it by the Buyer. In case of any such postponement, the price of the products affected shall be the price in effect on the date of final shipment. When released, orders are subject to standard lead times which will be calculated from the release date.

6) **MINIMUM ORDERS.** Orders with a value of \$100.00 or less may be accepted for processing or not at Kaba Ilco's option.

7) **ORDER MODIFICATIONS.** Kaba Ilco will accept changes to purchase orders until they have been entered into our order processing system. Once an order has been entered, changes are permissible only with approval.

8) **DELIVERY; FAILURE TO ACCEPT DELIVERY.** Shipping schedule estimates are based on our best judgment and are not guaranteed, nor can these estimates be considered legally binding. Kaba Ilco will notify Buyer if for any reason it is unable to deliver the Products as scheduled, and Kaba Ilco cannot be held liable for any damages of any nature resulting from these delays. If Buyer fails to accept delivery at the scheduled time, the purchase price shall become due and payable in accordance with the payment terms set forth herein, and all risks associated with the Products or parts of the Products to be delivered, shall be borne by the Buyer. Buyer shall be responsible for all storage and handling costs incurred and to be incurred as a result thereof.

9) **FREIGHT ALLOWANCE.** All shipments are F.O.B. Rocky Mount, NC, USA. The risk of loss related to the Products shall transfer to Buyer when the Products are accepted by the carrier. Any cartage, inside delivery or handling charges between freight destination and customer warehouse

are to be paid by the customer. Freight will be prepaid on orders for \$1,750 or more net to one destination within the 48 contiguous states and Canada by the routing of our choice. If customer specifies other routing, the difference will be invoiced. Priority shipments are not prepaid and may be subject to special handling charges. Should Buyer request a shipping method or carrier different than Kaba Ilco's standard, then the full amount of the shipping cost will be invoiced to the Buyer.

10) **TITLE.** Ownership of the Products shall remain with Kaba Ilco until full payment of the sale price has been received. Until complete payment has been received, Buyer undertakes to warrant and keep the goods free and clear of all liens, other charges or encumbrances.

11) **DROP SHIP POLICY FOR KEY CUTTING MACHINES.** This policy applies to both mechanical and electronic key cutting machine models:

a) Kaba Ilco Corp., if requested, will drop ship key cutting machines. Provided the value of the machine(s) meets the minimum prepaid shipping policy of \$1,750 there will be NO freight charges added. If the value of the machine(s) is less than \$1,750 the freight charges will be added to the invoice.

b) Drop shipped machines will be priced at WDN with no additional special pricing or discounts.

c) This policy applies to key cutting machines ONLY. Other Ilco, Silca, or Advanced Diagnostics branded products cannot be included.

d) Due to documentation requirements that include invoice pricing to cross the US Border, no machines or products will be drop shipped outside the United States.

12) **CLAIMS.** All claims for shipping and invoicing differences must be submitted within 10 working days after receipt of shipment. Upon request, Kaba Ilco will provide the customer with information necessary to secure Proof of Delivery from carrier.

13) **RETURNS.** All requests to return goods must be approved in advance by Kaba Ilco and must be made within six months from date of invoice. No merchandise is to be returned without a Return Goods Authorization number from Kaba Ilco. A Return Goods Number will be assigned and a label will be sent from the factory for the returnable merchandise only. This number must be marked clearly on the outside of the carton(s) to assure proper handling. Return Goods Numbers are valid for only 60 days from day of issue. All components must be included in one package even if broken or defective. All returns are to be shipped prepaid and are subject to a handling charge, and may be subject to a restocking fee. Product(s) made to order are not returnable. The issuance of a Return Goods Number does not imply that credit will be issued. All credits issued will be based on our acceptance after inspection of the returned item(s).

14) **MINIMUM ANNUAL SALES VOLUME.** Kaba Ilco reserves the right to discontinue direct sales to any customer who does not meet the minimum annual sales volumes. The minimum annual sales volumes are set at the time an account is opened with Kaba Ilco and are based on markets served and other relevant factors.

15) **PROMOTION OF PRODUCTS.** Buyer shall sell and promote the Products in a manner which will enhance the image and good will of Kaba Ilco. The use of Kaba Ilco's trademarks and name is strictly prohibited without prior written consent of Kaba Ilco.

16) **SOFTWARE AND PRODUCT DOCUMENTATION.** Certain of Kaba Ilco's products may have software and/or firmware either included with or embedded in the products (the "Software") and may include product documentation. This Software and Product Documentation section applies to those Products that include either Software or product documentation.

LICENSE: Subject to Buyer's timely payment in full of all amounts owed to Kaba Ilco pursuant to the Order, as of the date of receipt of the applicable Products, Kaba Ilco grants to Buyer a non-exclusive, non-transferable, revocable (as permitted herein) license to use the Software solely in connection with the Products, and to use the product documentation in connection with the operation of the Products; in each case, solely in the course of Buyer's normal business operations.

Kaba Ilco shall retain all title, right and interest, including all intellectual property rights, in and to all of the Software and product documentation except for the express license rights granted to Buyer in these Terms. Subject to Buyer's timely payment in full of all amounts owed to Kaba Ilco pursuant to the Order and compliance with the terms of this Section, Buyer shall have the right to use the Software in perpetuity so long as the Software is used only in connection with the Products. In no event may Buyer use the Software to establish a duplicate system at any other location. Notwithstanding any other provision of these Terms, except as necessary to fulfill Kaba Ilco's warranty obligations under these Terms, Buyer is not entitled to receive any update, upgrade or other release of the Software other than the Software embedded in or included with the product when shipped. Any update, upgrade or other release of the Software not included at the time of shipping of a product may be subject to additional charges.

b) **RESTRICTIONS:** Buyer shall not, and shall not permit any third party to: (i) copy, modify, or create derivative works or improvements of the Software or product documentation; (ii) remove, disable, or otherwise create or implement any workaround to, any security features contained in the Software; (iii) remove, delete or alter any trademarks, copyright notices, or other intellectual property rights notices of Kaba Ilco or its licensors, if any, from the Software or product documentation; (iv) rent, lease, lend, sell, sublicense, assign, distribute, publish, transfer, or otherwise make the Software or product documentation available to any person or entity; or (v) reverse engineer, disassemble, decompile, decode, adapt, or otherwise attempt to derive or gain access to the source code of the Software, in whole or in part.

c) **LICENSE TERMINATION:** Kaba Ilco has the right to terminate any or all of the rights granted to Buyer pursuant to this Section, upon notice to Buyer, if Buyer breaches any of the terms of this Section.

17) WARRANTY.

a) Kaba Ilco's standard Limited Warranty for the Products that is in effect as of the date of the order shall apply to Buyer's purchase of the Products. b) **DISCLAIMER OF WARRANTIES:** EXCEPT AS EXPRESSLY SET FORTH HEREIN AND IN KABA ILCO'S STANDARD LIMITED WARRANTY FOR THE PRODUCTS, KABA ILCO MAKES NO WARRANTIES OF ANY KIND OR NATURE FOR ANY PRODUCTS, SOFTWARE, OR SERVICES, INCLUDING WITHOUT LIMITATION, ANY WARRANTIES OF QUALITY, CONDITION, DESCRIPTION, COMPLIANCE WITH SAMPLE, PERFORMANCE, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT, WHETHER ARISING BY LAW, COURSE OF DEALING, COURSE OF PERFORMANCE, USE, OR TRADE, WHETHER EXPRESS, IMPLIED, STATUTORY, OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.

18) **LIMITATION OF LIABILITY.** The total liability of Kaba Ilco for all claims of any kind whether in contract, tort or otherwise, arising out of, connected with, or resulting from Kaba Ilco's performance or breach of these Terms, or Products or services furnished hereunder, shall in no event exceed the total purchase price for the Products or services in the Order giving rise to the claim. Kaba Ilco shall not under any circumstances be held liable for loss of profits or revenues, loss of use of product or any other product software, system, or facility, loss of data or information, lack or loss of productivity, interest charges or cost of capital, cost of substitute product, software, systems or services, cost of purchases or replacement power, downtime costs, special damages, incidental damages, liquidated damages, special damages, or consequential damages.

19) **ASSIGNMENT.** Buyer may not assign any rights or obligations under the Order without prior written consent of Kaba Ilco. Kaba Ilco may assign or transfer all of its rights and obligations under the Order without Buyer's consent to any successor or entity pursuant to a merger, spin-off, conversion, or other corporate reorganization or restructuring, a change of control, or the sale of all or substantially all of its assets, so long as the assignee assumes all obligations of Kaba Ilco under the Order. For all permitted assignments, these Terms shall bind and inure to the benefit of

the parties and their successors and assigns. This section will survive the expiration or termination of the Order.

20) **TERMINATION.** If Buyer does not fulfill its obligations or is in default or breach of these Terms, Kaba Ilco may then terminate the Order by notice in writing. Kaba Ilco has the right to claim compensation for any loss it incurs as a result of Buyer's default, in addition to any other rights or recourse available to Kaba Ilco at law or in equity.

21) **MODIFICATIONS, AMENDMENTS, AND WAIVERS.** These Terms may not be modified or amended, including by custom, usage of trade, or course of dealing, except by an instrument in writing signed by duly authorized representatives of both Buyer and Kaba Ilco. Performance of any obligation required of a party under these Terms may be waived only by a written waiver signed by a duly authorized representative of the other party, which waiver shall be effective only with respect to the specific obligation described therein. The waiver by either party of a breach of any obligation of the other shall not operate or be construed as a waiver of any subsequent breach of the same provision or any other provision of these Terms.

22) **FORCE MAJEURE.** Should a delay in performance (including production and/or delivery) be caused by a Force Majeure event, the time of performance shall be extended by a reasonable amount of time with regard to all applicable circumstances. Upon mutual agreement, the parties shall set a new date for performance. Except as to payments due hereunder, neither party shall be liable for failure to perform hereunder for the duration of and to the extent such failure is occasioned by a Force Majeure event which is defined as follows: war, riots, insurrections, fire, flood, extreme weather, explosions, strikes and other labor or industrial disturbances, accidents, Government, State, Provincial or Municipal regulations and/or ordinances, an act of God, embargos, blockades, delay in obtaining materials, legal restrictions, currency regulations, or any cause or condition beyond the reasonable control of the parties. Where such conditions continue for more than three (3) months, either party shall be free to terminate the Order. In the case of termination, Kaba Ilco shall be paid the value proportionate to the Order price for any finished Products and work-in-progress, if any, along with additional costs incurred as of the date of termination.

23) **APPLICABLE LAW.** These Terms and all Orders shall be governed by and construed in accordance with the laws of the State of North Carolina, USA, without regard to the conflict of law provisions thereof. For the purposes of all legal proceedings, the state and federal courts of Rocky Mount, North Carolina, USA, shall have the exclusive jurisdiction to entertain any action arising under these Terms and all Orders. Each party hereto hereby irrevocably attorns to the jurisdiction of the courts of Rocky Mount, North Carolina, USA.

24) WAIVER OF JURY TRIAL.

a) **WAIVER OF JURY TRIAL:** EACH PARTY HEREBY IRREVOCABLY WAIVES ITS RIGHTS TO TRIAL BY JURY IN ANY ACTION OR PROCEEDING ARISING OUT OF OR RELATING TO THESE TERMS OR THE TRANSACTION OR TRANSACTIONS RELATING TO ITS SUBJECT MATTER, INCLUDING ANY AND ALL ORDERS.

25) **SEVERABILITY.** Any term, condition or provision of these Terms, or any part thereof, which is or may be found to be prohibited or unenforceable in any jurisdiction shall, as regards such jurisdiction and to the extent of such prohibition or unenforceability, be deemed to be severed from these Terms, and the remaining terms, conditions and provisions of these Terms shall remain in full force and effect.

26) **ENTIRE AGREEMENT.** These Terms and any related quotations constitute the entire understanding and contract between the parties and supersede any and all prior and contemporaneous, oral or written representations, communications, understandings, and agreements between the parties with respect to the subject matter hereof. The parties acknowledge and agree that neither of the parties is entering into the Order on the basis of any representations or promises not expressly contained in these Terms and any related quotation(s).

27) **EXPORT LAW ASSURANCES.** Kaba Ilco's products and services are solely intended for the United States (including United States territories), Canada, the Caribbean islands (including the Dominican Republic). Any activities outside of these regions are prohibited and are not supported by Kaba Ilco.
